6TH ANNUAL CONVENTION OF THE PHILIPPINE ASSOCIATION

1. The Philippine Association of Education Supervisors, Inc. (PAES, Inc.) will hold its 6th Annual Convention at Bohol Tropics Hotel, Tagbilaran City on November 3-5, 2005 with the theme "PAES: Committed to Achieve Quality Assurance".

2. The convention aims to:

- a. equip education supervisors with the necessary competencies in achieving quality assurance;
- b. increase the level of awareness of education supervisors on the different DepED programs and projects;
- c. attain a heightened commitment of education supervisors to achieve quality assurance; and
- d. strengthen and sustain the bond of relationship among PAES members.

3. Participants to this convention are education supervisors (regional and division supervisors) and division subject coordinators. The regional directors and schools division superintendents are advised to allow their supervisors to attend on official time only considering that this convention is a once a year opportunity for the PAES members to meet and discuss ideas.

4. A registration fee of Three Thousand Eight Hundred Pesos (Php3,800.00) shall be charged each participant to defray expenses for hotel accommodation, meals, honoraria of speakers, convention kit and operational expenses. This shall be charged against local school board funds or other sources. Only cash payments will be accepted. Early registration will be accepted through the Regional Board Member.

5. Participants are expected to register in the afternoon of Wednesday, November 3, 2005. First meal shall be served in the evening of the said date and the last meal (lunch) on Friday, November 5, 2005. All PAES officers and Board of Directors are expected to arrive at the venue on Tuesday, November 2, 2005 for convention preliminaries. Enclosed is the Schedule of Activities.
