ORIENTATION/TRAINING OF TLE TEACHERS OF THE S & T ORIENTED (ESEP) HIGH SCHOOLS AND THE LEARNING RESOURCE CENTERS

To: Regional Directors
Schools Division/City Superintendents
Heads, S & T Oriented High Schools and Learning Resource Centers

- 1. The Bureau of Secondary Education (BSE) of this Department will conduct an Orientation/Training of Technology and Livelihood Education (TLE) Teachers of the S & T Oriented (ESEP) High Schools and Learning Resource Centers at the Robbinsdale Hotel, No. 14 Araneta Avenue, Cor. Palanza St., Quezon City on October 24-25, 2005 (first batch) and October 26-27, 2005 (second batch).
- 2. The activity shall acquaint and update teachers on the content and methodologies in teaching/learning of TLE.
- 3. Participants shall be the second year teachers of Electrical and Electronics, Civil Technology, ICT Education, and Agri-Fisheries of the 110 S & T Oriented (ESEP) High Schools and Learning Resource Centers. There shall be a maximum of only two teachers (1 teacher from each specialization) per school as indicated by the specialization offered by the school and identified by the principal during the March 19, 2005 meeting at the Bulwagan ng Karunungan.
- 4. However, there shall be only one batch of orientation/training for Agri/Fisheries. Teachers of \$ & T Oriented HS and Learning Resource Centers teaching Agri/Fisheries in the second year from Regions I-XIII, CAR and NCR are requested to register at 6:00 p.m. on October 23, 2005.
- 5. The first batch of participants from Regions I, II, III, IV-A, IV-B, V and NCR are requested to register at 6:00 p.m. on October 23, 2005 and check out of the venue in the afternoon of October 25, 2005. The second batch of participants shall come from Regions VI, VII, VIII, IX, X, XI, XII, XIII and CAR and are requested to register at 6:00 p.m. on October 25, 2005. All participants are requested to bring to the orientation/training venue reference materials and lesson plans.
- 6. Travel allowance and per diem of participants shall be charged against local funds whereas board and lodging, honoraria for trainers, rental of computers shall be charged against BSE funds. The extra duty allowance, TEV of BSE staff and

supplies/materials incident to the orientation in the amount of Ninety Five Thousand Five Hundred Six Pesos (PhP95,506.00) shall be charged against the unexpended funds for the development of Learning Competencies for the revised curriculum of the S & T Oriented (ESEP) HS, subject to the usual accounting and auditing rules and regulations.
