TRADITIONAL AND ALTERNATIVE HEALTH CARE MONTH CELEBRATION

- 1. Pursuant to Presidential Proclamation No. 698 dated August 19, 2004, the Traditional and Alternative Health Care Month Celebration will be observed during the whole month of November. This mandate aims to generate awareness on the importance of promoting the use of traditional and alternative health care among the studentry in all public and private schools.
- 2. School health and nutrition personnel and health education supervisors at the regional and division levels are encouraged to take the lead in conducting various activities related to said celebration in their respective areas. Coordination shall likewise be made with the regional program managers of the Department of Health's Philippine Institute of Traditional and Altenative Health Care (DOH-PITAHC) and other involved GOs and NGOs.
- 3. Health and Nutrition staff and all school physicians are likewise invited to attend on official time only the convention on the Power of Natural Healing to be conducted by PITAHC and PCAM on the following dates and venues:

- 4. A registration fee of Three Hundred Pesos (PhP300.00) per participant and an accommodation fee of One Thousand Two Hundred Pesos (PhP1,200.00) per day for full-board (live-in) and Eight Hundred Pesos (PhP800.00) for live-out will be charged.
