## REGIONAL NAPSSHI CONFERENCE ON EDUCATIONAL LEADERSHIP AND MANAGEMENT

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Elementary and Secondary Schools

- 1. In consonance with the Basic Education Sector Reform Agenda (BESRA) and in line with its strategy for improving basic education through the Schools First Initiatives (SFI), the National Association of Public Secondary School Heads, Incorporated (NAPSSHI) will hold the Regional Conferences on Educational Leadership and School Management in partnership with Microsoft-Philippines, Center for Learning & Teaching Styles (CLTS), Philippines and the Philippine Business for Social Progress (PBSP).
- 2. In each of the activities the association aims to:
  - a. develop a Blueprint for Secondary Education Reforms Initiative;
  - b. formulate School Improvement Plans (SIP) along the five Key Reform Thrusts;
  - c. strengthen Leadership Skills and School Based Management Competence (SBMC) towards building the 21<sup>st</sup> Century Schools.
- 3. The maiden implementation shall be held on November 23, 24, and 25, 2005 at Chateau Royale, Batulao, Nasugbu, Batangas.
- 4. The participants to attend on official business are Assistant Schools Division Superintendents (ASDs), ASDs-Designate, Public School Heads, Head Teachers, Teachers-in-Charge (TICs), National Officers and Board Members of NAPSSHI, PESPA and PAES. Those from private institutions may make arrangement with their administrators relative to the attendance.
- 5. A conference fee of Three Thousand Eight Hundred Pesos (PhP3,800.00) shall be charged each participant to defray expenses for board and lodging, honoraria of speakers, conference materials/kits and operational expenses. Travel expenses and registration fee shall be charged to local funds subject to the usual accounting and auditing rules and regulations.
