An intelligence report submitted to this Office reveals that Mr. FRANCISCO N. AGODOYO, claiming to be the Assistant Executive Director of the Presidential Service Monitoring Group (PSMG), is the head of a dubious organization using the name and seal of the Office of the President.

Mr. Agodoyo was apprehended last 19 March 2002 by OG2, PSG and charged before MTC of Manila for violation of Executive Order No. 141, "Prohibition against Forgery and Unauthorized Use of the Seal of the President of the Philippines". In spite of this case, Mr. Agodoyo still engages in anomalous/criminal activity. Last 17 August 2004, Mr. Agodoyo and his companions were arrested by the Surigao City Police and charged with "Usurpation of Authority" at the Office of the City Prosecutors. Mr. Agodoyo has since been banned from entering the Malacañang Complex

Everyone is advised not to entertain him and to disregard any transaction with him or his organization. If he attempts to misrepresent himself or appears in any government office, it is best to immediately report his presence to the PSG at 735-6201 loc 3002 and 733-8967.
