GUIDELINES IN THE IMPLEMENTATION/CONDUCT OF THE 2006 CHED NATIONAL SCHOLARSHIP

THE 2006 CHED NATIONAL QUALIFYING EXAMINATION (NSQE)

23 November 2005

In accordance with the pertinent provisions of Republic Act No. 7722, otherwise known as the "Higher Education Act of 1994," and pursuant to the Commission en banc (CEB) Resolution No. 636-2005, the following shall govern the conduct of the NSQE:

I. Objective:

The goals of the Commission on Higher Education (CHED) is to broaden the access of deserving and qualified Filipinos to higher education opportunities in accordance with the Constitutional mandate that "the State shall establish & maintain a system of scholarship, grants, student loan programs, subsidies and other incentives which shall be available to deserving students in both public and private schools, especially to the underprivileged" (Art XIV, sec. 2 (3).

The NSQE shall serve as a safety net to ensure quality and shall provide an objective tool in identifying the target beneficjaries/grantees under the various Student Financial Assistance Programs.

II. Coverage

The NSOE shall be administered to all entering college freshmen applicants nationwide.

III. Qualification of Applicants

To qualify for the NSQE, the applicant must meet the following qualifications:

- 1. He/she must be a Filipino citizen:
- He/she must be a high school graduate or a candidate for graduation from high school;

- 3. He/She must have a general average of 85% (if applying for Scholarship) or 80% (if applying for grants);
- 4. The parents income should not exceed One Hundred Fifty Thousand pesos (P150,000.00) per annum;
- 5 He/She must be in good physical condition and of good moral character, and;
- 6 He/She must not be more than thirty years of age at the time of application.

IV. Application Procedures

Applicants shall:

- secure Application Form at the CHED Regional Offices, CHED Office of Student Services, or download to <u>www.ched.gov.ph</u>;
- 2. submit accomplished Application Form together with required documents to CHED Regional Offices;
- 3. deadline of application 15 January 2005;
- 4. take the NSQE in designated time, date, venue; and
- 5 wait for the examination result.

VI. Obligations of CHEDROs

- 1. Inform the public on the NSQE;
- 2. issue Application Forms;
- 3. receive and deposit payments of application fees to designated accounts/banks;
- 4. screen and prepare list of qualified examinees;
- 5. provide OSS with a list of examinees, test centers, and rooms;
- 6. issue official notice to examinees including testing center, date, time, and room;
- 7. provide logistics to protect the integrity of the examination;
- 8. arrange for the use of Testing Center (50 examinees/room);

- 9. select local test proctors (1 proctor/room);
- 10. submit list of proctors to OSS;
- 11. arrange for board and lodging, transportation (to/from airport, to/from testing venue) of Examiners coming from Manila; and
- 12. disseminate official result of examination to examinees.

VII. Obligation of OSS

- 1. Advertise to inform the public re NSQE;
- 2. coordinate with test administrators;
- 3. provide CHEDROs application forms, and posters;
- 4. issue Application Forms;
- 5. receive and deposit payments of application fees to designated account/ bank;
- 6. provide logistics to protect the reliability and integrity of the examination;
- 7. serve as overseer of the conduct of the NSQE;
- 8. provide list of examinees to PNU; and
- 9. release official results to CHEDROs for dissemination.
