12TH WORLD CONFERENCE IN EDUCATION

To: Bureau Directors

Heads, Public and Private Elementary and Secondary Schools

1. The World Council for Curriculum and Instruction (WCCI) Philippines Chapter, shall host the 12th World Conference in Education on August 7-12, 2006 at the Manila Hotel, Manila, Philippines with the theme "Building a Culture of Peace For a Civil Society".
2. The WCCI is a transnational educational organization committed to advancing the achievement of a just and peaceful world community through collaboration in curriculum and instruction projects, dialogue on educational and social issues of a global nature and promote person-to-person contact and professional network. It is a non-government organization (NGO) of the United Nations in consultative status with the Economic and Social Council (ECOSOC).
3. Participants to this conference are DepED Central Office officials, regional directors, assistant regional directors, schools division superintendents, assistant schools division superintendents, public and private school administrators, supervisors, subject area specialists, master teachers, researchers, guidance counselors, community developers and other service personnel.
4. Arrangements for substitute teachers must be made to ensure that the classes of participating teachers will not be disrupted.
5. The registration fee for each participant will cover expenses for meals, conference materials, and certificate. Participants from public schools may charge their registration fees from local funds subject to the usual accounting and auditing rules and regulations. The registration fees are as follows:

Seven Thousand Pesos (PhP7,000.00)	For early registrants (before April 30, 2006) for WCCI members
Nine thousand Pesos (PhP9,000.00)	For non-WCCI members
Ten Thousand Pesos (PhP10,000.00)	For on-site registration for WCCI members
Eleven Thousand Pesos (PhP11,000.00)	For non-WCCI
