- 1. The Department of Education (DepED) through the National Education Testing and Research Center (NETRC) will conduct a Workshop/Conference on the Administration of Reading Test in English and Filipino for Grade III and National Achievement Test for Year I (Regular and Bridge), Year II (as per DepED Order No. 27, s. 2005), Grade VI, and Year IV (as per DepED Order No. 5, s. 2005).
- 2. The workshop/conference aims to equip division testing coordinators with regards to the guidelines in the standardized administration of the said tests.
