GENDER AND DEVELOPMENT (GAD) PROGRAMS

- 1. In response to strengthening the GAD mandates, particularly Republic Act No. 7129 entitled "Women in Development and Nation Building Act", an Act Promoting the Integration of Women as Full and Equal Partners of Men in Development and Nation Building and R.A. 9262, "Prevention of Violence Against Women (VAW) and Children", the Staff Development Division-Human Resource Development Service (SDD-HRDS) will conduct the Gender and Development (GAD) Programs for CY 2006.
- 2. The objectives of the program are to:
 - a. raise gender awareness among the participants enabling them to be more committed and responsive to gender equality;
 - b. facilitate the concept of mainstreaming gender concerns in the Department in accordance with the provisions of R.A. 7192;
 - address different VAW and Sexual Harassment concepts and issues;
 and
 - d. assess the status of the GAD programs in the regions in sustaining GAD Advocacy efforts.
- 3. Participants are HRMOs/AOs for training, secretaries, executive assistants, information officers and other technical staff who will serve as trainors in the succeeding conduct of regional/division GAD programs. Each participating regions is to send 20 participants except for Regions II, VII and VIII with 30 participants each. For the All Males Gender Sensitivity Training Program, regions shall send 5 participants each. The regional offices shall determine the composition of the regional delegation, ensuring that the division offices are represented. The rest of the regions not covered by this memorandum will have their training in 2007.
- 4. Please refer to the enclosure for the titles, schedules and venues. Travel expenses and per diem (before and after the training) of participants are chargeable against local funds, while board and lodging of participants, and project staff, travel expenses and per diem of (before and after the training) of resource speakers, facilitators and project staff, supplies and materials, honoraria of resource speakers, extra duty allowance of facilitators and project staff, contingency funds and other incidental expenses of the training shall be charged against Special Program Funds, subject to the usual accounting and auditing rules and regulations.
