NATIONAL WORKSHOP CONFERENCE FOR ALTERNATIVE LEARNING SYSTEM (ALS) KEY OFFICIALS

- 1. The Bureau of Alternative Learning System (BALS), Department of Education will conduct a National Workshop Conference for Alternative Learning System (ALS) Key Officials on May 16-18, 2006 at Teachers Camp, Baguio City.
- 2. The primary objective of the workshop conference is to serve as an avenue for the ALS Field officials/implementors for (a) sharing of experiences and information for updates on the new trends /innovations and best practices; (b) orientation on the utilization of the newly developed basic literacy learning materials; (c) setting of targets/benchmark on program implementation; and (d) threshing out issues/problems and concerns particularly in the implementation of the ALS programs and projects in the grassroots level.
- 3. Participants to this workshop conference are twenty (20) BALS officials and selected staff, thirty four (34) Regional ALS Chiefs and Assistant Chiefs representing the seventeen (17) regions, and one hundred eighty seven (187) Alternative Learning System (ALS) Division/City Supervisors.
- 4. The Chiefs and Assistant Chiefs are requested to bring the following data:
 - Literacy data disaggregated by sex and division;
 - Quantitative accomplishment on the various ALS programs; and
 - List of existing CLCs and specific sites.
- 5. Board and lodging of the participants will be charged to BALS funds while the participants' transportation and other incidental expenses will be charged to local funds, subject to the usual accounting and auditing rules and regulations. Registration and settling in of participants starts in the afternoon of May 15, 2006 and dinner will be served on this day. Departure will be after breakfast of May 19, 2006.
