METROBANK FOUNDATION NETWORK OF OUTSTANDING TEACHERS AND EDUCATORS (NOTED) GENERAL ASSEMBLY AND NATIONAL TRI-LEVEL TEACHERS' AND EDUCATORS' CONFERENCE

- 1. The Metrobank Foundation, Inc., in coordination with the Department of Education (DepED) as a major partner in the Search for Outstanding Teachers, announces the holding of the Metrobank Foundation Network of Outstanding Teachers and Educators (NOTED) General Assembly and the NOTED National Tri-Level Teachers' and Educators' Conference.
- 2. The NOTED General Assembly will be held at the Manila Doctors College, Diosdado Macapagal Avenue, Pasay City on Wednesday, October 25, 2006. The General Assembly will focus on sharing of best practices in teaching as well as the election of officers of NOTED.
- 3. The NOTED National Tri-Level Conference for Teachers and Educators will be held at the Century Park Hotel, Pablo Ocampo Sr. St., Malate, Manila on October 26-27, 2006. The theme of the Conference is "Excellence in Education Tomorrow: A Commitment and a Responsibility Today."
- 4. The objectives of the conference are to: a) promote excellence in teaching at all levels elementary, secondary, and tertiary; b) share researches and experiences that highlight excellence in education; and c) demonstrate excellent teaching practices and educational innovations. The Conference activities include plenary sessions, concurrent sessions, and poster sessions highlighting researches that promote excellence in education; demonstration lessons focusing on teaching innovations; exhibits and special sessions.
- 5. Participants to the conference are teachers, administrators, and educators in the elementary (including pre-school), secondary (including Alternative Learning Systems), and tertiary levels.
- 6. Transportation and other allowable expenses of participants may be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations. The on-site registration fee for the conference is Four Thousand Pesos (PhP4,000.00) and Three Thousand Five Hundred Pesos (PhP3,500.00) for the early bird (until June 30, 2006); and Three Thousand Five Hundred Pesos (PhP3,500.00) for on-site registration of NOTED members and Three Thousand Two Hundred Pesos (PhP3,200.00) for the NOTED early bird. The amount will cover food, supplies and materials.
