## TEACHERS' ORIENTATION / CONSULTATION ON CIVIL SERVICE RULES AND REGULATIONS ,DEPED THRUST AND CONSULTATION ON EXECUTIVE ORDER NO. 180

- 1. In response to strengthening the spirit of partnership under EO 180, entitled Right of Government Employees to Self Organization ,Registration and Accreditation and in consonance with DepEd Order no. 51 s of 2003, Teachers Orientation on Public Sector Unionism, this Department will conduct a one day Teachers' Consultation/Orientation. - 2. The objectives of the orientation /consultation are to:
- a. orient the teachers of the Civil Service Rules and Regulations
- b. provide adequate information on the right to self organization, Registration and Accreditation under EO 180

- 4. Travel expenses of participants are chargeable against local funds subject to the usual accounting and auditing rules and regulations. Unions/association having budget of their own may send more than I representative provided that the organization has to confirm the attendance to the secretariat.
- 5. An amount of P 100.00 shall be collected from each participant to cover the lunch and snacks.
