2006 SEARCH FOR THE OUTSTANDING HOME ECONOMISTS SERVICE AWARD (HESA)

To: Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Elementary and Secondary Schools

- 1. The Philippine Home Economics Association (PHEA), a recognized national association of home economists founded in 1948 by well-known educator and former Senator Helena Z. Benitez and Philippine Home Economics Foundation (PHEF) in coordination with the Department of Education, announces the 2006 Search for the Outstanding Home Economists Service Award (HESA).
- 2. The Search is designed to give honor and recognition to home economics teachers in the elementary and secondary levels whether public or private schools who exhibited outstanding accomplishments and service for the last ten (10) years. This will also help develop, promote and uphold the profession by encouraging others to be model and emulate the excellent example of the awardees. Specifically, it aims to:
 - a. encourage home economists to promote the welfare and strengthen the family as a basic unit of society and by serving as role models in home economics education;
 - b. give recognition and honor to home economists for their service in the home, school and community;
 - c. raise the standards of the home economics profession; and
 - d. inspire other home economists to emulate the outstanding accomplishments of the awardees.
- 3. The Search is open to Home Economists, Edukasyong Pantahanan at Pangkabuhayan (EPP) for elementary and Technology and Livelihood Education (TLE) for secondary teachers in public and private schools. The nominee, to be qualified for nomination must:
 - a. be a life member to be nominated for the Service Award;
 - b. be a Home Economics degree or any other degree with specialization in Home Economics and other allied areas and/or field in Home Economics;

- c. be a Filipino citizen, male or female, morally upright and has no record of criminal, civil, administrative conviction;
- d. accomplish and submit the required Information Sheet on time (please see timetable) together with the necessary supporting documents, certified under oath as true and correct (regional level);
- e. be officially indorsed by the school/institution shall be honored:
- f. be within three (3) years of continuous outstanding performance rating (July 2002 to July 2005); and
- g. not be a previous awardee. Principals, supervisors and teachers who were previous awardees and/or past presidents of the PHEA and those who are current officers and board members including their first degree relatives, are not eligible for nomination.
- 4. There will only be one (1) regional awardee either elementary or secondary level from the public or private school. The 2006 Outstanding Home Economists Service Award will be chosen from among the regional awardees. The implementing guidelines, criteria for selection and accompanying nomination form are enclosed.
- 5. Below is the timetable of the Search:

- 6. The awarding ceremony will be held at the ECOTECH, Cebu City during the PHEA Annual Convention on November 4-6, 2006. Each regional winner will receive Ten Thousand Pesos (PhP10,000.00), certificates of recognition and participation, a plaque/trophy, roundtrip fares and accommodation courtesy of Focus Global Incorporated. The national winner will receive another cash award of Ten Thousand Pesos (PhP 10,000.00) and a trophy.

General Screening Procedures:

- 1. Three (3) screening committee on the HESA Award in each category shall be recognized-division, regional and national level screening.
- 2. The official criteria formulated by the PHEA Awards Committee shall be adopted on all levels by all screening committees and shall be used by the board of judges.
- 3. Judging shall be based on verifiable supporting documents, submitted results of interview and other means decided upon by the national contest committee.
- 4. The decision of the screening committee in all levels shall be final.



COMPETENCE AND EFFECTIVENESS

- A. Competence in work as home economist (TLE-EPP) in education/community service. Submit evidences showing competence in nominee's field such as performance ratings, etc. signed by the head of school/office/organization.
- B. Effectiveness in terms of goals depending on service area where home economist (TLE-EPP) is involved in. Submit certifications and other evidences showing effectiveness in profession for the past 3 years, transfer of learning by students (for educators) from school to home, or livelihood skills taught to community through training (for community service).

PROFESSIONAL AND COMMUNITY IMPACT

- A. How did the nominee helped improve the home economics profession? Submit evidences of contributions that has helped in the improvement of the home economics profession and quality family life such as awards, recognitions, etc.
- B. How did the nominee's work as home economist affected her community and/or members of the community. Submit evidences such as certifications, photographs, awards, recognition, appreciation that show impact of nominee to community.
