NATIONAL TRAINING FOR DEPED SCHOOL SPORTS COACHES

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Secondary Schools

- 1. In response to the needs of teacher-coaches/trainers, the Department of Education through the Task Force on School Sports (TFSS) shall conduct the **National Training for DepED School Sports Coaches** on May 26-30, 2006 at Teachers Camp, Baguio City.
- 2. The training aims to enhance the skills and competencies of teacher-coaches/trainers in coaching, conditioning and training student-athletes in the following sports disciplines: archery, arnis, athletics, badminton, baseball, basketball, boxing, chess, football, gymnastics, sipa/sepak takraw, softball, swimming, taekwondo, table tennis, tennis and volleyball.
- 3. The participants to this training are teachers, ceaches, trainers who meet the following requirements:
 - a. must be physically and mentally fit; and
 - b. must possess knowledge and skills in any of the abovementioned disciplines.
- 4. Participants are likewise required to bring with them their sports attire, rubber shoes, and rackets (for racket sports).
- 5. A registration fee of Four Thousand Eight Hundred Pesos (PhP4,800.00) shall be charged each participant to cover board and lodging, training kit, transportation going to and from the training venue, extra essential services of management staff and other related expenses. Registration fee, transportation, per diem and other incidental expenses to be incurred by the participants shall be charged against local funds. Board and lodging, transportation, per diem, honoraria of resource persons and other incidental expenses shall be charged against A.II.d.1 funds subject to the usual accounting and auditing rules and regulations.
