MUSIC AND ARTS TEACHING MADE EASY FOR NON-MAJORS

To: Regional Directors
 Schools Division/City Superintendents
 Heads, Public and Private Secondary Schools

1. In order to address the needs of teachers teaching MAPEH, the Department of Education, through the Bureau of Secondary Education, shall conduct a training for teachers with no specialization in music and arts.
2. The training entitled **Music and Arts Teaching Made Easy for Non-Majors** aims to develop the KSAs of teachers teaching Music and Arts as a component of MAPEH in the Basic Education Curriculum. It will focus on content, teaching and evaluation strategies.
3. Participants to the training are MAPEH teachers who are not majors but are teaching Music and Arts. Each division shall send one (1) teacher for Music and one (1) for Arts. Regional and division MAPEH supervisors, as well as teachers from private schools are encouraged to attend the training.
4. The schedule of the training is as follows:

5. The registration fee shall cover expenses for the board and lodging of participants, honorarium of resource persons, extra duty allowance of the training staff and other incidental expenses relative to the training. Registration fee, transportation, per diem and other incidental expenses to be incurred by each participant shall be charged against local/school funds, while board and lodging, transportation, per diem of the training staff and resource persons, supplies and materials shall be charged against BSE funds.
