INTEL TEACH TO THE FUTURE 2006 SUMMER ACTIVITIES

The EW aims to enhance the knowledge and skills of the participants on the pedagogical themes of the Intel Teach to the Future Program and to prepare Regional and Master Trainers to plan for TMT in selected schools and provide pedagogical support to new Master Trainers from said schools. The TMT intends to help teachers to effectively utilize the potentials of technology in their respective subject areas.

On the other hand, the SPW aims to provide an overview of the use of ICT in education and to introduce strategic planning as a tool in designing and implementing an ICT in education program.



On the other hand, the participants in the SPW are Division and School Heads and ICT Coordinators from the same selected divisions and schools.
