iSCHOOLS - COMMUNITY e-CENTER PROJECT

To: Regional Directors
Schools Division/City Superintendents
Heads of Selected Public Secondary Schools

- 1. The Commission on Information and Communications Technology Human Capital Development Group (CICT-HCDG), in coordination with this Department, House of Representatives, Local Government Units (LGUs) and Non-Government Organizations (NGOs) shall implement the **iSchools Community e-Center Project** (iSchools CeC Project) starting School Year 2006 2007.
- 2. The Project intends to contribute to the efforts of the government to bridge the digital divide by developing an educational digital network that will provide all public high schools access to relevant content and applications to enhance teaching and learning. More specifically, the Projects aims to deliver the following:
 - a. Internet laboratory with broadband internet access, network peripherals, unlimited free one-year internet connectivity for the first year and one (1) server and twenty (20) workstations; and
 - b. Training of teachers, laboratory managers and principals on the use of ICT in teaching and learning, networking concepts and maintenance procedures and on the establishment of support systems and mechanism; and
 - c. CeC training and Monitoring and Evaluation (M & E).
- 3. Initially, the Project shall benefit seventy-two (72) public high schools. The list of recipient-schools is enclosed. Funds for the Project shall be sourced out from selected members of the House of Representatives through the eGovernment Fund.
- 4. The Regional ICT Coordinators through their respective Division ICT Coordinators shall coordinate the implementation of the Project and report on the progress of project implementation to Ms. Maria Victoria D. Abcede, BSE (telefax number 632-7586) or Engr. Ariel V. Rodriguez, CICT-HCDG (telefax number 920-7412).
- 5. Immediate and widest dissemination of this Memorandum is desired.
