
DepED MEMORANDUM

iSCHOOLS WEBBOARD TRAINING PROGRAM

To: Regional Directors
Schools Division/City Superintendents
Heads of Selected Public Secondary Schools

1. The Commission on Information and Communications Technology – Human Capital Development Group (CICT-HCDG), in coordination with this Department, LMI-Philippines/USAID and Intel Technology Philippines, Inc. (ITPI) shall conduct the iSchools Webboard Training Program between May 15 to June 2, 2006 at the DepED/PIL-IT Academy Center, 4th Floor Bonifacio Bldg., DepED Complex, Pasig City.
2. The training program aims to train teachers on the management of an instructional website for e-learning. More specifically, the training intends to:
 - a. define the common language, objectives, packages and technology needed to implement e-learning;
 - b. build a common understanding of the instructional design/plan to integrate digital technology resources in the subject areas across the BEC;
 - c. create a course instructional plan template that incorporates modalities of e-learning and content from readily available digital repositories;
 - d. design and create an e-learning webboard;
 - e. review and use curricular content and standard references from the World Wide Web for possible integration in the prescribed curricular offerings of the Department; and
 - f. work with/navigate the software that can provide access to the internet.
3. Participants in the training are one teacher each of English, Science and Mathematics from each of the selected high schools. Enclosed is the schedule of activities including the list of schools that shall send participants to the aforementioned training.
4. The Regional ICT Coordinators through their respective Division ICT Coordinators shall select the participants on the basis of the following qualifications:
 - a. A minimum teaching experience of five (5) years and with a permanent appointment;
 - b. Fifty (50) years of age or younger;
 - c. With basic computer literacy skills; and
 - d. Good at spoken and written English.

5. LMI-Philippines/USAID and ITPI shall cover the costs of meals, accommodation and other expenses relative to the conduct of the training. Traveling and other incidental expenses of the participants, however, shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
