LINKING AND VALIDATION OF THE REFINED 2002 BASIC EDUCATION CURRICULUM (BEC) WITH THE STAKEHOLDERS

- 1. The Bureau of Secondary Education, in collaboration with the Bureau of Elementary Education, this Department, will conduct the **Linking and Validation of the Refined 2002 Basic Education Curriculum** at the Bulwagan ng Karunungan, Rizal Building I, DepED Complex, Meralco Avenue, Pasig City on May 16-19, 2006.
- 2. The activity aims to:
 - a. orient different stakeholders of education on the proposed refinements of the BEC;
 - b. gather feedback from the participants; and
 - c. discuss sectoral issues and concerns relative to the proposed refinements.
- 3. The participants to this activity are the experts from the academe, principals, head teachers, supervisors, teachers, representatives from teacher organizations, representatives from industry, Chair-Senate Committee on Education, Chair-Committee on Basic Education, House of Representatives, Governors, Mayors, Barangay Chairman, Chiefs/Assistant Chiefs of Secondary Education Division, and consultants of different learning areas.

Board and lodging of participants, honorarium of resource persons and consultants, supplies and materials, extra duty allowance of the training staff and other incidental expenses relative to the training shall be charged against BSE funds while travel expenses and per diem of the participants shall be charged against local/school funds subject to the usual accounting and auditing rules and regulations.
- 5. Participants are advised to proceed to the DepED Central Office, Meralco Avenue, Pasig City on May 16, 2006 at 7:00 a.m. for the registration. The program will start at 10:00 a.m. Live-in participants shall be billeted in nearby hotels after the afternoon session.
