PILOT SECONDARY SCHOOLS TRAINING OF FIRST YEAR TEACHERS ON THE REFINED SECONDARY EDUCATION CURRICULUM

To: Regional Directors

Schools Division/City Superintendents

1. The Bureau of Secondary Education (BSE), this Department will conduct a 5-day training program for first year teachers of the twenty-four (24) selected pilot schools in the implementation of the refined secondary education curriculum. The training will be done in two clusters:

- 2. The training program aims to pilot the first year curriculum proposal and design as a result of the curriculum review and refinement conducted with the various stakeholders by the Bureau of Secondary Education. It seeks to orient and train the participants on the conceptual organization and performance standards including teacher competency of the first year curriculum, hopefully improving the performance level of the students.
- 3. The training program will be participated by nine (9) first year teachers and the principals of the pilot schools: English (1); Filipino (1); Mathematics (1); Science (1); Araling Panlipunan (1); TLE (1); MAPEH (1 PE and Health and 1 for Music and Arts); and Edukasyon sa Pagpapahalaga (1).
- 4. Regional Directors and Schools Division Superintendents are requested to allow the participation of those concerned.
- 5. Board and lodging of participants, transportation costs (by land and sea only, to be reimbursed upon presentation of official receipt), travel expenses of BSE staff, honoraria of resource persons, extra duty allowance of BSE staff shall be charged to the BSE funds, subject to the usual accounting and auditing and regulations.
