MEMBERSHIP AND RESPONSIBILITIES OF THE NATIONAL COORDINATING COUNCIL'S (NCCE) TECHNICAL WORKING GROUPS

- 1. With the creation of the National Coordinating Council of Education (NCCE) mandated by Executive Order No. 273, s. 2000, the Secretary of the Department of Education (DepED), the Chairman of the Commission on Higher Education (CHED), and the Director General of the Technical Education and Skills Development Authority (TESDA) composing the Council have identified the NCCE thrusts.
- 2. The Council, during its meeting on April 25, 2006, discussed and approved three resolutions which would enable the Council to address the NCCE thrusts and ensure effective planning, coordination and implementation of its functions:
