


POST-PALARONG PAMBANSA CONFERENCE

Schools Division/City Superintendents

- 1. The Department of Education (DepED) through the Task Force on School Sports (TFSS) shall conduct the **Post-Palarong Pambansa Conference** at the ECOTECH Center, Lahug, Cebu City on July 4-5, 2006.
- 2. The conference aims to assess the 2006 Palarong Pambansa and revise the screening and technical guidelines of the Palarong Pambansa.
- 3. The participants (list enclosed) shall be the Regional PESS chiefs/heads of the Regional TFSS, regional representatives to the 2006 Palarong Pambansa Screening Committee, selected tournament managers, key officials of the Technical Management and Games Administration (TMGA), and TFSS staff.
- 4. A registration fee of Four Thousand Pesos (PhP4,000.00) shall be charged each participant to cover board and lodging and other incidental expenses.
