## ANNUAL SEMINAR-CONVENTION IN HOME ECONOMICS

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents

Heads, Public and Private Elementary and Secondary Schools

- 1. The Philippine Home Economics Association (PHEA), in coordination with the Department of Education, will hold a three-day **Annual Seminar-Convention in Home Economics (EPP-TLE)** on November 4-6, 2006 at DepED Ecotech, Lahug, Cebu City.
- 2. The theme of the convention is "Quest Towards a Culture of Excellence in Home Economics." The program of activities will focus on active participation in the teaching-learning demonstrations of regional winners in the different areas/component of TLE-EPP both in the content and laboratory lessons. The participants will be involved in critiquing/evaluation of the demonstration lessons.
- 3. The objectives of the convention are to:
  - a. possess a clearer perspective of the emerging role of Home Economics as a Science and as an Art;
  - b. analyze the role and challenges of Home Economics teaching and learning in the instructional cycle;
  - c. identify innovative teaching techniques that develop critical thinking, problem solving and decision-making skills; and
  - d. plan alternative approaches to respond to the social, economic, moral and spiritual needs of the students to improve the quality of family life.
- 4. Participants to the convention are regional and division supervisors, principals and school heads of Technology and Livelihood Education (TLE originally THE and EPP) TLE chairman and coordinators; EPP teachers, Agriculture and Industrial Arts teachers, DepED-TLE scholars representing their respective regions; regional PHEA coordinators and PHEA regional, division and school level officers. Participants are advised to bring their PHEA Identification Cards.
- 5. Attendance of the participants shall be on official business. A registration fee of Three Thousand Five Hundred Pesos (PhP3,500.00) shall be charged each participant to cover expenses for food and accommodation, conference kits, certificates,

medals/trophies, instructional materials and other incidental expenses chargeable against local funds subject to the usual accounting and auditing rules and regulations. Participants from the private schools may make necessary arrangements with their respective institutions.
