CLUB 100: DEVELOPING AND MANAGING CURRICULUM INNOVATIONS

- 1. As a continuing effort to assist the schools that have initiated curriculum innovations, the Department of Education through the Bureau of Secondary Education (BSE) shall conduct the third seminar-workshop for Club 100 on Developing and Managing Curriculum Innovations from August 28 to September 1, 2006 at Teachers Camp, Baguio City.
- 2. The seminar-workshop aims to assist school heads and head teachers in packaging curriculum innovations, getting grants and influencing stakeholder's support for curriculum innovations.
- 3. The participants are those who have attended any or both of the previous training programs on Developing and Managing Curriculum Innovations (DMCI). They are requested to bring a copy of their curriculum innovation plan/s.
- 4. A registration fee of Four Thousand Eight Hundred Pesos (PhP4,800.00) shall be charged each participant to cover board and lodging, seminar kit, honoraria of resource persons, supplies and materials, extra duty allowance of training staff and other incidental expenses.
- 5. The registration fee, transportation, per diem and other incidental expenses to be incurred by the participants shall be charged against local funds, while training venue rentals, and transportation of management staff shall be charged against BSE funds subject to the usual accounting and auditing rules and regulations.
