GUIDELINES FOR THE 2007 ALTERNATIVE LEARNING SYSTEM  
ACCREDITATION AND EQUIVALENCY (A&E) TEST

To: Bureau Directors  
Regional Directors  
Schools Division/City Superintendents  
Heads, Public and Private Elementary and Secondary Schools

1. The 2007 Alternative Learning System – Accreditation and Equivalency (ALS A&E) Tests (elementary and secondary levels) will be administered in 187 divisions in four waves:

- 1<sup>st</sup> Wave - February 4, 2007 - Mindanao Regions
- 2<sup>nd</sup> Wave - February 11, 2007 - Visayas and Bicol Regions
- 3<sup>rd</sup> Wave - February 18, 2007 - Luzon Part I (Regions I, II, III and CAR)
- 4<sup>th</sup> Wave - February 25, 2007 - Luzon Part II (Regions IV-A & B, and NCR)

2. Registration period will be from September 1 to October 25, 2006. All registrants shall register in duly designated Registration and Testing Center (RTC) identified by the Schools Division Superintendent (SDS). A duly appointed ALS District Coordinator shall serve as Test Registration Officer (TRO) in the Registration and Testing Center. The RTC in each division shall be announced later.

3. The following orientation schedules will likewise be observed:

a. Regional Orientation for Test Registration and Test Administration

Date : August 16-18, 2006 (Regions I, II, III, V and CAR)  
August 17, 2006 (NCR, Regions IV-A and IV-B)  
August 30-September 1, 2006 (Regions VI, VII, VIII,  
IX, X, XI, XII, CARAGA and ARMM)

Venue : Regional Office


Participants : Regional ALS Division Chiefs  
ALS Division Supervisors  
ALS District Coordinators (Test Registration Officers)

- b. Division Orientation for Test Administration (two days before the actual conduct of the test)

Date : Wave 1 - February 2, 2007  
Wave 2 - February 9, 2007  
Wave 3 - February 16, 2007  
Wave 4 - February 23, 2007  
Venue : Division Offices/Registration and Testing Centers  
Participants : **Testing Center Administrator (Principal or Head of Schools)**  
Schools Division Superintendents and/or Assistant  
Schools Division Superintendents  
District Supervisors  
Examiners, Proctors, Janitors and Security Guards

4. Other information pertinent to the 2007 ALS A&E Tests are provided in the enclosed guidelines for widest dissemination and appropriate action of all concerned.
