

DepED MEMORANDUM No. 292, s. 2006

TWENTY-SIXTH NATIONAL SECONDARY SCHOOL ADMINISTRATORS CONGRESS

- 1. The Philippine Association of Secondary School Administrators (PASSA) in coordination with the Bureau of Secondary Education (BSE) announces the holding of the Twenty-Sixth National Secondary School Administrators Congress on October 16-20, 2006 at Teachers Camp, Baguio City. The theme of the Congress is **The Principal Leading the Way in Empowering Communities.**
- 2. The Congress aims to:
 - a. define the landscape of community empowerment as a vehicle to enhance school outcomes;
 - b. identify support system for effective school governance; and
 - c. strengthen school community partnership in the pursuit of school improvement.
- 3. Participants to this Congress are private and public secondary school principals/assistant principals, teachers-in-charge or officers-in-charge, administrators, schools superintendents and assistant schools superintendents and regional supervisors in charge of secondary education, chiefs and assistant chiefs of Secondary Education Division, and heads of secondary trade-agriculture-fisheries schools. Designated committee members are authorized to travel two days before the Congress. Attendance is on **official business**. This Congress shall foster renewed vibrance among the DepED family in the pursuit of its sectoral agenda to support the government's sustainable development goals.
- 4. A registration fee of Four Thousand Five Hundred Pesos (PhP4,500.00) shall be charged each participant to cover expenses for board and lodging, conference materials and kits, honoraria of speakers, etc. The first meal shall be dinner of October 16. Traveling expenses and registration fee shall be charged to local funds subject to its availability and the usual accounting and auditing rules and regulations.
- 5. Each region is requested to prepare a 5-minute cultural presentation with 10 or more members.
