- 1. The Philippine Cooperative Center (PCC) announces the conduct of the 8th National Cooperative Summit on October 4-6, 2006 at the Puerto Princesa City Coliseum, Palawan. The theme of the Summit which is a biennial gathering of cooperative leaders and advocates, is "Cooperatives: Making a Real Difference (Bansang Nagkakaisa, May Pusong Kooperatiba)."
- 2. The objectives of the Summit are to:
 - unite the broadest number of cooperatives under a common policy, technical and business agenda to advance the cooperative movement in various endeavors and lines of economic and non-economic activities;
 - highlight the existing initiatives, projects, achievements and policy positions of cooperatives and of their respective networks or apexes;
