- 1. Travel expenses and per diem (before and after the training) of participants are chargeable against local funds, while board and lodging of participants and staff and travel expenses, per diem (before and after the training), extra duty allowance of the facilitators and staff and other incidental expenses of the training are chargeable against Special Program Funds subject to the usual accounting and auditing rules and regulations.
