7th ANNUAL NATIONAL CONVENTION OF THE PHILIPPINE ASSOCIATION OF EDUCATION SUPERVISORS, INC. (PAES, Inc.)

To: Regional Directors
Schools Division/City Superintendents

- 1. The **Philippine Association of Education Supervisors**, Inc., (PAES, Inc.) will hold its 7th Annual National Convention on November 13-16, 2006 at Legend International Resorts Ltd., Waterfront Road, Subic Bay Freeport Zone, Zambales, Philippines 2200 with the theme "Building Capacity of ES in Supporting SBM".
- 2. The three- day event aims to:
 - a. provide a venue for articulation between supervisors and among educators;
 - b. update them on the current programs and projects of the Department;
 - c. build the ES capacity to strengthen the quality of educational leadership;
 - d. equip ES the necessary knowledge, skills and attitudes in providing support to school based management; and,
 - e. attain a heightened commitment of ES to support SBM.
- 3. Participants to this convention are all regional and division education supervisors and subject area coordinators. Members of the different working committees are considered participants and shall pay the registration fee.
- 4. A registration fee of Four Thousand Two Hundred Pesos (PhP 4,200.00) shall be charged each participant to defray expenses for hotel accommodation, meals, honoraria of resource speakers, and other operational expenses. For preparatory activities, the committee members are expected to be at the venue two (2) days before the activity. Participants are expected to register in the afternoon of Monday, November 13, 2006. First meal shall be the dinner on the said date while the last meal (packed snacks) shall be served on November 16, 2006. Attendance to this convention will be on **official business**.
- 5. Travel expenses incident to the attendance to this convention as well as the registration fee, shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations.
