CREATION OF A COMMITTEE TO SELECT THE DEPED UNIFORM FOR SY 2007-2008

Assistant Secretaries
Bureau Directors
Regional Directors

Directors of Services/Centers and Heads of Units
Heads, Public and Private Elementary and Secondary Schools
All Others Concerned

- 1. In order to facilitate the selection of uniforms for officials and employees of the Department of Education, a Uniform Committee is hereby created to select the DepED uniform for SY 2007-2008.
- 2. For SY 2007-2008, there shall be two (2) national uniforms, one (1) regional uniform and one (1) division uniform. The uniform for the teaching personnel shall be different from that of the non-teaching personnel or the administrative support staff. For this purpose, teaching personnel shall be the teachers as defined in RA 4670, or the Magna Carta for Public School Teachers.
- 3. The Uniform Committee shall be tasked to:
 - a. facilitate the selection of the two (2) sets of national uniforms from among several designs submitted by uniform designers for the DepED officials and employees teaching and non-teaching personnel, male and female; and
 - b. determine the mode of distributing the clothing allowance for CY 2007 and the method of procuring the clothing materials for the selected uniforms.
- 4. The uniform designs that will be selected by the Committee shall be presented to the MANCOM and EXECOM for approval, as well as the mode of distributing the clothing allowance and the method of procuring the clothing materials.

5. The Uniform Committee shall be composed of representatives from the different sectors of the Department and constituted as follows:
