NATIONAL SEMINAR-WORKSHOP ON THE PROCEDURES OF SCREENING OF PARTICIPANTS IN THE PALARONG PAMBANSA

- 1. In order to protect the integrity of the Palarong Pambansa and to ensure that there will be no recurrence of incidences of cheating in the fielding of athletes, and as recommended by the Fact Finding Committee on the Anomalous Incidents in the 2006 Palarong Pambansa chaired by Undersecretary Franklin C. Sunga, the Task Force on School Sports (TFSS) of the Department of Education shall conduct the National Seminar-Workshop on the Procedures of Screening of Participants in the Palarong Pambansa at the Quirino Hall, Teachers Camp, Baguio City on January 23-25, 2007.
- 2. The seminar-workshop aims to update participants on the Rules on Eligibility of Athletes as provided for in the 2007 Palarong Pambansa Technical Guidelines, and provide an avenue for participants to share insights and experiences in the discharge of their tasks as members of the screening committees.
- 3. Participants shall be the chairmen and members of the screening committees in the regional meets, heads of the screening committees in the division meets, regional representatives to the National Screening and Accreditation Committee (NSAC) of the 2007 Palarong Pambansa, selected members of the Technical Management and Games Administration Committee of the Palarong Pambansa and Regional PESS Chiefs/Heads of Regional TFSS.
- 4. A registration fee of Three Thousand Five Hundred Pesos (PhP 3,500.00) shall be charged each participant and members of the management staff to cover board and lodging, seminar materials, extra duty allowance of management staff, and other related expenses. The registration fee, transportation, per diem and other incidental expenses to be incurred by the participants shall be charged against local funds, while registration fee, transportation, and per diem, of management staff shall be charged against A.II.d.1 funds.
- 5. Immediate dissemination of this Memorandum to all concerned is desired.
