CONDUCT OF ECHO TRAINING ON THE SCHOOL MAPPING EXERCISE AND ORIENTATION OF THE GIS-BASED SCHOOL PROFILE SYSTEM

To: Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Elementary and Secondary Schools

- 1. The Department of Education, through the Physical Facilities and Schools Engineering Division (PFSED) launched the DepED School Mapping Exercise Project nationwide and simultaneously conducted the orientation on the GIS-Based School Profiling System, utilization and proper filling up of survey tools. The mechanics of implementation of the School Mapping Exercise and GIS-BASED School Profiling Project is contained in DepED Memorandum No. 362, s. 2006.
- 2. One of the outputs expected from participants is the conduct of information dissemination on what were taught during the activities in their respective regions/divisions given the national plan of action and electronic copies of all the theories taken up as basis in scheduling and undertaking the project down the school level.
- 3. In view of this, the conduct of echo training, information dissemination on the School Mapping Exercise and the orientation on the GIS-Based School Profiling System at the Region/Division and School Levels is necessary to ensure the efficient and effective implementation of the project. The Office of Physical Facilities and Schools Engineering Division, Office of Planning Service (PFSED-OPS) will provide speakers/resource persons and technical assistance during the Echo Training upon invitation from the regions/divisions.
- 4. Participants to the Echo Training are Assistant Schools Division Superintendents, Administrative Officers, Supply Officers, Planning Officers, Physical Facilities Coordinators, District Supervisors, Public Elementary and Secondary School Principals.
- 5. The creation of a School Mapping Committee at the region/division/district and school levels is necessary to properly organize the system and delineate functions, duties and responsibilities of each member to ensure smooth implementation of the project.

- 6. Expenses relative to the echo training are chargeable against local funds, while the Central Office shall provide electronic copies of the survey tools and speakers/resource persons. The GIS-Based School Profiling System survey tools provided in CD forms shall be reproduced and distributed to the School Heads/Principals by the region/division.
- 7. Immediate and wide dissemination of this Memorandum is desired.
