TRAINING OF TRAINORS ON THE CFSS (CHILD FRIENDLY SCHOOL SYSTEM)
MODELING PROCESS

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Secondary Schools

1. The Child Friendly Schools System (CFSS), a project of UNICEF in collaboration with this Department, was piloted in eight (8) public secondary schools in 2006. In order to prepare the divisions for assisting the schools, and the regions for guiding the divisions in implementing the program, a Two-Cluster Training of Trainers on the CFSS Modeling Process shall be conducted for Education Supervisors designated as CFSS coordinators, and LGU Chairs of the Education Committee on February 5-9, and February 12-16, 2007, at venues to be announced later.

2. The purpose of the training is to upgrade the competencies of the Coordinators and LGU representatives in:


- a. interpreting survey results;
- b. managing the process of conducting focus group conversations (FGCs);
- c. listening and reflective responding;
- d. action planning;
- e. progress monitoring; and
- f. reviewing action plans.

3. The participants in the training are the regional and division supervisors designated as CFSS coordinators of the 24 school/city divisions of the CFSS and the LGU Chair of the Committee on Education of these provinces/cities. Enclosed is the list of participants.

4. The board and lodging and other incidental expenses to be incurred shall be charged against project funds. The transportation and other allowable traveling expenses of all participants shall be reimbursed during the said activity, subject to the usual accounting and auditing rules and regulations.
