- 1. The Philippine Federation of Teachers and Employees' Cooperatives (PFTEC), an umbrella organization of duly registered teachers' cooperatives and in cognizance of its complementary role in strengthening the registered teachers and employees' cooperatives in DepED, announces the schedule of its series of skills training programs from February 2007 to March 2007.
- 2. Generally, the series of skills training programs aims to enhance the compliance of cooperatives to financial performance standards, operations, capacity and efficiency of these cooperatives thus adhering to the cooperative principles of the International Cooperative Alliance (ICA) and International Cooperative Identify Statements (ICIS) and in compliance to CDA's monitoring, supervision and regulation of cooperatives. These training programs are also in line with the obligation of cooperative to provide education and training for their members, elected representatives, managers and employees in order that they can contribute effectively to the development of their respective cooperatives and to keep the general public informed, especially the youth and opinion leaders, about the nature and benefits of cooperation.
- 3. Participants to the PFTEC training programs are cooperative officials and managers as indicated in the enclosed training calendar and training design. School officials are enjoined to allow the officers of duly registered teachers' cooperatives to participate in the training programs, on **official time only**, pursuant to Chapter III, Article 28 of R.A. 6938.
- 4. The cost of registration fees indicated in the enclosure for live-in session seminars includes one (1) night accommodation, one full board meals, and materials. For live-out sessions, meals (lunch and snacks only) and materials.
- 5. All expenses incurred including registration fees to the PFTEC training programs shall not be chargeable against the funds of the Department of Education.
