2007 PPSTA SEARCH FOR OUTSTANDING TEACHERS, SCHOOL HEADS AND DIVISION CHAPTERS

A. CRITERIA FOR THE PPSTA SEARCH FOR OUTSTANDING TEACHERS, SCHOOL HEADS, AND DIVISION CHAPTERS (School Year 2006-2007)

I. RATIONALE:

The Philippine Public School Teachers Association (PPSTA) in cooperation with the Department of Education (DepEd) will conduct this year 2007 a nationwide Search for Outstanding PPSTA Teachers, School Heads and Division Chapter. This activity is the highlight of the forthcoming celebration of the 60th FOUNDATION ANNIVERSARY OF THE PHILIPPINE PUBLIC SCHOOL TEACHERS ASSOCIATION.

The Search aims to recognize the exemplary and outstanding PPSTA teacher-members and the local PPSTA chapters in the country. This also bestows honor to the teaching profession by recognizing teachers who devote their lives to the development of the youth and the achievement of quality education.

II. OBJECTIVES:

- 1 Recognize exemplary and outstanding PPSTA member teacher and school official who made significant contributions to the advancement of the teaching profession and of the PPSTA.
- 2 Promote leadership and excellence in professional conduct and service through active involvement in PPSTA whether at the Division, Regional and National level.
- 3 Encourage and inspire members of the Association to work for the enhancement of the reputation and image of PPSTA thru exemplary dedication to their profession as educator and school officials.

III. SCOPE OF THE PROGRAM

The Program shall apply to all PPSTA members who are in the active service of the Department of Education (DepEd) as classroom teachers or school heads in the elementary and secondary schools, provided they meet the qualification requirements set in the Guidelines of the National Search and Award Committee 2006-2007. It will also include Division Chapter affiliated with the Regional and National PPSTA.

IV. WHO MAY NOMINATE

1. Any active member of PPSTA may nominate for the awards.

V. NOMINATION DOCUMENTS

The following should be submitted to the National Office.

- 1. Properly accomplished PPSTA nomination form. There are three (3) categories for nomination for the Awards.
 - 1.1. Nomination for Outstanding Classroom Teacher to be accomplished by the nominator and nominee.
 - 1.2. Nomination for Outstanding School Head to be accomplished by the nominator and nominee;
 - 1.3. Nomination for Outstanding Division Chapter to be accomplished by the nominator and Regional Chapter President.
- 2. The nomination form should have the complete information as this will be the same form to be used by the National Search Committee for evaluation.
- 3. The summary of accomplishments shall be certified and authenticated by the nominee, nominator and chairmen of the Division/Regional Committee.
- 4. Personal Data Sheet with recent passport size $(1 \% \times 1 \%)$ photo of the nominee duly subscribed and sworn to

before the Administrative Officer in the employing agency.

- 5. Duly authenticated pertinent documents to support the claim for the awards received or duly authenticated outstanding performance (award, publication, etc.)
- 6. Copy of the minutes of the deliberation(s) on the nomination by the Division/Regional Search Committee.
- 7. Three (3) nomination folders containing the above mentioned documents should be submitted to the PPSTA National Search Committee: c/o Mr. Francisco E. Josef and Ms. Begornia Parong.

VI. DISQUALIFICATION

Previous National Winners of similar search sponsored by other organizations are disqualified.
