ADOPTION OF PROGRAM IMPLEMENTATION PLAN, 2006 VERSION

1. Enclosed is the official 2006 version of the Program Implementation Plan covering activities in four (4) initial areas of the Basic Education Sector Reform Agenda (BESRA) in support of the EFA 2015 Plan, namely:

- a. School-Based Management (SBM)
- b. Competency-Based Teachers Standards (CBTS)
- c. Quality Assurance and Accountability Framework (QAAF)
- d. Outcomes-Focused Resource Mobilization

2. The actions outlined in the 2006 PIP operationalizes some of the policy directions announced in the 2006 State of Education Address of the Secretary of Education ("New Directions, New Hopes") at the National Educators Congress last December 5, 2006 at Teachers Camp, Baguio City, Philippines.

3. The 2006 PIP also serves as the guiding document for implementing selected activities in the annual DepED budget the costs of which are eligible for financing by the \$200-Million budget-support loan of the World Bank (National Program Support for Basic Education Project). The official adoption of the 2006 PIP meets the conditions of the said loan, which became effective last January 1, 2007.

4. In addition, the 2006 PIP also serves as the indicative guide for the implementation of forthcoming AusAID grant assistance to the Philippine Basic Education Sector. As part of activating this AusAID grant assistance, a supplement to this 2006 PIP will be adopted to cover those specific activities to be financed by AusAID funding.

5. The PIP document is going to be an evolving plan. The management of DepED is committed to regularly and continuously update this plan as new needs, knowledge and ideas emerge in the course of attaining the country's Education for All 2015 goals and objectives. Once details for actions are defined and finalized in other areas, such as Information and Communications

Technology (ICT), Alternative Learning Systems (ALS), Madrasah Education, Early Childhood Education, among others, additions or revisions will be incorporated in future versions of the PIP.

6. Until later versions are adopted and issued, the 2006 PIP shall be the basic guide for schools, divisions, regions and central office in carrying out their respective roles and functions in the various activities.

7. Immediate dissemination of and compliance with this Memorandum is desired.
