- 1. The Metrobank Foundation, Inc. (MBFI), the Mathematics Teachers Association of the Philippines (MTAP), and the Department of Education (DepED) announce the 2007 Metrobank-MTAP-DepED Challenge National Finals and Awarding Ceremony on April 13-14, 2007.
- 2. The National Individual Finals (Written) shall be held on April 13, 2007 at 1:30-3:30 p.m. at the Main Function Room, Kabayan Hotel. The General Orientation will follow at the same venue at 3:30 p.m. The National Oral Finals (Individual and Team) will be held on April 14, 2007 at the Metrobank Plaza Auditorium, Sen. Gil Puyat Avenue, Makati City. Registration starts at 7:30 a.m., while the opening ceremony will immediately follow. The awarding ceremony will be at 5:00 p.m.
- 3. All individual and team contestants and team coaches shall be billeted at Kabayan Hotel, 2278 Zamora St., Rotonda, Pasay City with tel. nos. (02) 891-7874; 834-5574; 702-2700. Participants are expected to be at the hotel **before noon on April 13, 2007**. The concerned Metrobank Branches shall make the travel arrangements. The provincial delegates must contact Dr. Soledad J. Dilao thru cel. no. 0917-8378016 or Mr. Raymond San Juan thru cel no. 0917-8484772 so that they will be informed whether MTAP could arrange transportation to pick them up from the airport or bus terminals. If needed, delegates must inform the MTAP officers (Dr. Dilao and Mr. San Juan) of their expected time of arrival and carrier or means of transportation.
- 4. Travel, accommodation and meal expenses of all contestants and individual/team coaches will be shouldered by MBFI.
- 5. Regional Directors, Regional Math Supervisors, concerned Division Superintendents and Math Supervisors are hereby authorized to attend on official time. Travel and other incidental expenses may be charged to local funds, subject to its availability and the usual accounting and auditing rules and regulations. Other participating parties shall source their own funds for expenses they may incur relative to this activity.
