TRAINING-WORKSHOP FOR IMPLEMENTERS OF THE SPECIAL PROGRAM IN THE ARTS

To: Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Secondary Schools

- 1. The Department of Education (DepED) through the Bureau of Secondary Education (BSE) shall conduct a Training-Workshop for the Implementers of the Special Program in the Arts (SPA) on May 16-20, 2007 at Teachers Camp, Baguio City.
- 2. The training-workshop aims to enhance the competencies of teachers and coordinators in implementing the program. This year's theme "The Arts for a Better World", will focus on the enhancement of artistic skills, new trends in the different fields of art, as well as the development of the pedagogical skills in the different art forms.
- 3. The participants to the training-workshop are SPA teachers and coordinators from a) the 15 pilot schools; b) the new schools implementing the program; and c) schools that are planning to implement the program and division/regional coordinators. There will be simultaneous sessions for the basic and advanced groups, and also a separate session for coordinators of the program.
- 4. A registration fee of Four Thousand Five Hundred Pesos (PhP4,500.00) shall be charged each participant to cover expenses for the board and lodging, honoraria of resource persons for the advanced group, extra duty allowance of the training staff, training kit, transportation of the participants to and from the practicum venue and other incidental expenses relative to the training-workshop. Registration fee, transportation, per diem and other incidental expenses to be incurred by the participants shall be charged against local/school funds, while board and lodging, transportation per diem of the training staff and resource persons, honoraria of resource persons for the basic group, rental of session halls and equipment, supplies and materials and other incidental expenses shall be charged against BSE funds. All expenses are subject to the usual accounting and auditing rules and regulations.
- 5. Enclosed are the Participant's Profile to be accomplished by the participants, and the Confirmation Form which should be submitted not later than three (3) weeks before the training.
