The Curriculum Development Division, Bureau of Secondary Education (CDD BSE) this Department is currently conducting a Refinement of the Secondary Education Curriculum (RSEC). RSEC Year I pilot test was undertaken in SY 2006-2007. This will be continued in SY 2007-2008 with RSEC II and III. Thus, a writeshop on the Development of Year II and III curriculum documents and other related activities will be conducted on the dates and venues indicated below:

## The activities aim to:

- orient the writers on the Concept Process Model (CPM) being used in the curriculum refinement;
- develop the curriculum documents and planning guides for Year II and III;
- validate with different stakeholders the proposed curriculum documents; and
- finalize the outputs for teachers training.
- Participants to the development of curriculum documents and planning guides are selected Head Teachers from 23 pilot schools (two (2) per school) to be identified by BSE, selected Master Teachers, and subject area teachers. On the other hand, participants to the Consultation and Validation with Stakeholders are experts from academe, representatives from NGOs, representatives from government organizations such as DOH, NCCA, DOST, DTI, DSWD, representatives from barangay, parents from pilot schools and principals.
- Board and lodging of participants (in all activities) and BSE staff, transportation, extra duty allowance of BSE, supplies and materials and other expenses shall be charged against BSE Project Funds subject to the usual accounting and auditing rules and regulations.
- Immediate dissemination of this Memorandum is desired. 5.
