
THE SECOND INTERNATIONAL CONGRESS ON EDUCATION  
OF THE YOUTH IN LOVE, SEX AND LIFE

1. The InterMedia, an international Rome and Chicago-based foundation that promotes family and education values; EDUCHILD Foundation, Inc., a Philippine-based private initiative of parents that foster sound and healthy family life and child education; and the DAWV, a foundation that works for women volunteerism and poverty alleviation in collaboration with I Am S.T.R.O.N.G. of the University of Asia and the Pacific and the Bureau of Secondary Education announce the holding of the Second International Congress on Education of the Youth in Love, Sex and Life at EDSA Shangri-La, Pasig City, on November 19-22, 2007, with the theme "**Love, Laughter and Life Ever After**".
2. The congress aims to encourage and train participants to initiate activities and programs on character education and education in human love for teenagers within their respective spheres of influence. It is intended for parents, school administrators, education officials, and university students. A competition series (thematic song composition, write-up, documentary video, and art representation) is also being organized to generate youth interest in the congress.
3. Each division is authorized to send the following delegation:
  - a. an official of the division office, preferably the Schools Superintendent or Assistant Schools Superintendent;
  - b. the President of the Division Federation of PCTAs;
  - c. the Division Values Education Supervisor; and
  - d. the Principal of a flagship secondary school.
4. Attendance to this congress is on official business. The congress fee is US\$125 or its peso equivalent to cover participation and materials, exclusive of board and lodging, chargeable to local school funds subject to the usual accounting and auditing rules and regulations.
