## NATIONAL TRAINING OF PTCA AND LGU-ORGANIZED PRESCHOOL TEACHERS AND DAYCARE WORKERS

- 2. The activity aims to:
  - a. equip preschool teachers and daycare workers of the ECE curriculum and standards for 5 years old children;
  - b. uplift preschool teachers with current trends in teaching preschool education, its methods and strategies; and
  - c. introduce proper and maximum utilization of didactic and preschool educational materials.
- 3. Participants to this activity are Regional EED Chiefs, Regional PS Coordinators, Division PS Coordinators, Teachers under PTCA and LGU-Organized Preschool Program and selected Daycare Workers.
- 4. Travel and incidental expenses to this activity shall be charged against OSEC-Preschool Continuing Funds subject to the usual accounting and auditing rules and procedures. Traveling expenses of the teacher participants shall be charged against local funds.
