ORIENTATION ON THE ADMINISTRATION OF THE NATIONAL CAREER ASSESSMENT EXAMINATION (NCAE) FOR FOURTH YEAR HIGH SCHOOL STUDENTS

To: Regional Directors
Schools Division/City Superintendents
Heads, Private Secondary Schools

- 1. The National Education Testing and Research Center (NETRC) shall conduct an Orientation on the Administration of the National Career Assessment Examination (NCAE) for Fourth Year High School students.
- 2. The National Career Assessment Examination (NCAE) for Fourth Year High School students shall be administered both in public and private schools on August 28, 2007.
- 3. The following shall be discussed in the said Orientation:
 - Proper conduct/administration of the test;
 - Security of test materials, delivery, retrieval scheme;
 - Allocation of test materials;
 - Information derived from the individual Certificate of Rating; and
 - Financial matters relative to test administration.
- 4. Authorized to attend are Division Testing Coordinators (DTCs) and Division Private Schools Supervisors (DPSSs).
- 5. DTCs are instructed to bring the actual enrollment of Fourth Year High School students (SY 2007-2008), both public and private schools in hard and soft (CD) copies.
- 6. The dates of the said Orientation are as follows:

- 8. All participants are advised to check in at 12:00 noon on the first day and check out at 12:00 noon the following day.
