17TH ANNUAL NATIONAL CONVENTION OF THE PAMBANSANG SAMAHAN PARA SA EDUKASYON SA PAGPAPAHALAGA (PSEP, INC.)

- 1. The Pambansang Samahan Para sa Edukasyon sa Pagpapahalaga (PSEP, Inc.) will hold its 17th Annual National Convention on November 27-29, 2007 at Angel's Hills Retreat and Formation House, Tagaytay City with the theme "Pamilya, Paaralan at Media: Triyadikong Balikatan Tungo sa Makataong Sambayanan".
- 2. The convention is intended to:
  - a. strengthen the social and moral responsibilities of the family, school and mass media in building a humane society;
  - b. enjoin the family, school and mass media to assume active and complementary roles in building a humane society;
  - c. enhance students' creative participation in the promotion and preservation of moral and cultural values through different contests.
- 3. The association will also hold its 5<sup>th</sup> Tagis Talino and Sayawit sa Edukasyon sa Pagpapahalaga Competitions and the 3<sup>rd</sup> On-the-Spot Poster Making Contest during the convention. Contestants for the Poster Making are advised to bring their own materials (1/4 illustration board, pencil, eraser, pastel crayons, etc.)
- 4. The 2007-2008 winners for the Search for Outstanding School-Based Values Education Program, VE Educator, and Model KPSEP Organization and Values Education Research will also be awarded. The guidelines for the first three searches as well as the tentative convention program are enclosed.
- 5. Participants to this convention are Values Education and Makabayan regional, division and district supervisors, principals, head teachers and teachers-in-charge, VE and Makabayan department heads, coordinators and teachers both in the elementary and secondary levels, guidance counselors, Journalism, Christian Living and Character Education teachers, PSEP and KPSEP national and local officers and members, PTCA officers and members, students and other interested parties.

- 6. A registration fee of Four Thousand and One Hundred Fifty Pesos (P4,150.00) shall be charged each PSEP participant and Three Thousand Eight Hundred Pesos (P3,800.00) each KPSEP participant. The fee is inclusive of board and lodging, convention materials, honoraria for resource persons and membership fees (for PSEP participants only). The fee is chargeable against local funds, school board funds and other sources subject to the usual accounting and auditing rules and regulations.
- 7. Regional directors, school division/city superintendents and school principals are encouraged to send participants to the convention and contests. The regional and division VE/Makabayan supervisors and coordinators shall undertake the coordination in the field pertaining to their respective delegation and representation.
- 8. The PSEP national officers and the Organizing Committee members are allowed to travel one day in advance to attend to the preliminary preparations for the convention.
- 9. Student-participants to the convention and contests shall be given enough time to prepare for the quizzes and other examinations which they may have missed because of their absences. They shall be allowed reasonable time to comply with other requirements of the different subject areas.
- 10. Registration is on a first-come, first-served basis on November 27, 2007. The first meal of the convention is breakfast of November 27, from 7:00-8:00 a.m.. In view of this, participants are requested to register before the said time.

#### **Qualification of Nominee**

- The school nominee must be presently offering Values Education both as a separate subject area and as integrated in the core subjects for the last three (3) years or more.
- 2. The school nominee must be recommended by the Division. Only one nominee per division will be accepted by PSEP.

#### **Selection Procedure:**

For the first level. All supporting documents (within the last three (3) years) submitted by the school nominees shall be rated according to a set of criteria presented below:
