**2-DAY ZONAL WORKSHOPS ON THE IMPLEMENTATION OF THE
EXPERIENTIAL LEARNING COURSES (ELCs): FIELD STUDY AND
PRACTICE TEACHING**

1. The Teacher Education Council (TEC), in coordination with the Regional Offices of the Department of Education (DepED) and the Commission on Higher Education (CHED), shall conduct **2-Day Zonal Workshops on the Implementation of the Experiential Learning Courses (ELCs): Field Study and Practice Teaching**. The activity is in support of the Education for All (EFA) core indicator for progress in basic education with teachers continuously improving their teaching practices. Guideposts to the ELCs are the Teacher Education and Development Program (TEDP) and the National Competency-Based Teacher Standards (NCBTS).
2. The zonal workshops aim to achieve the following objectives:
 - a. adopt the National Competency Based Teacher Standards (NCBTS) as an integrated framework that shall define dimensions of effective teaching and learning in all aspects of a teacher's professional life and development;
 - b. underscore the roles and responsibilities of the participants in the implementation of the ELCs; and
 - c. include interfacing activities of Basic Education Schools (BES) and the Teacher Education Institutions (TEIs) relative to the implementation of the ELCs in the Division Educational Development Plan(DEDP)/Annual Implementation Plan (AIP).
3. Participants to the zonal implementation workshops shall come from DepEd regional and division offices, CHED regional offices, and Teacher Education Institutions (TEIs). Participants from TEIs shall be invited by the City/Provincial Schools Division Superintendents. Enclosure No. 1 shows the clustering of regions, allocation of participants, venues and ~~schedules~~ per zone.

4. All expenses relative to board and lodging of the DepED and CHED/TEI participants, resource speakers, training staff and facilitators including supplies and materials, professional fees of resource speakers and extra essential allowance of the training staff shall be charged against the TEC fund.
5. Traveling expenses of resource speakers and training staff shall be charged against TEC fund while those of the participants shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
6. The DepED Regional Offices shall fax the list of participants to the TEC office at telefax 638-6172 not later than August 1, 2007. For further details, please get in touch with Dr. Beatriz G.
