NATIONAL SEMINAR/WORKSHOP FOR THE NATIONAL PROGRAM SUPPORT FOR BASIC EDUCATION (NPSBE) LOAN NO. 7393 PH

To: Regional Directors

1. The Department of Education is now implementing the \$US200M loan of the government from the World Bank to finance the reforms being undertaken by the government in basic education under the National Program Support for Basic Education (NPSBE).

- 2. In line with this, the DepED Central Office Accounting Division in coordination with the Educational Development Projects Implementing Task Force (EDPITAF), will hold clusters of seminars/workshops for the newly approved loan to orient finance people on the programs and projects anchored and supported by the loan, the preparation of statement of expenditures for reimbursement from the World Bank, necessary reports required by the oversight agencies and other issues and concerns regarding the implementation of this project.
- 3. The seminars/workshops shall be held at the ECOTECH Center, Lahug, Cebu City by cluster on the following dates (inclusive of travel time):

The participants in these seminars/workshops are Regional Finance Officers and Regional Accountants as well as their respective Division Accountants, Accountants and Budget Officers in the Central Office. Resident Auditors of Regional and Division Offices are likewise invited to attend for possible inputs that may be relevant for the efficient implementation of NPSBE.
- 5. A registration fee of Two Thousand Pesos (PhP2,000.00) chargeable against local funds shall be collected from each participant to cover supplies, workshop materials, contingencies and extra essential allowances of resource persons, speakers, facilitators and coordinators subject to the usual accounting and auditing rules and regulations.
