- 1. The National Education Testing and Research Center (NETRC) shall conduct an Orientation on the Administration of the Philippine Educational Placement Test (PEPT).
- 2. The Philippine Educational Placement Test (PEPT) shall be administered on November 18, 2007 for Luzon and on November 25, 2007 for Visayas and Mindanao. Last day of registration shall be on September 30, 2007.
- 3. The following shall be discussed in the said Orientation:
 - Proper conduct/administration.of the test;
 - Evaluation of documents;
 - Security of test materials, delivery, retrieval scheme;
 - · Allocation of test materials; and
 - Financial matters relative to test administration.
