2007 ANNUAL CONFERENCE OF THE PHILIPPINE HISTORICAL ASSOCIATION

1. The Philippine Historical Association (PHA) in consortium with the Department of Education (DepED) will hold its 2007 Annual Conference on September 21, 2007 at the National Library Auditorium, T.M. Kalaw St., Ermita, Manila with the theme "Controversies and Fallacies in Philippine History".

2. The PHA aims to:

- a. update teachers on the new studies and perspectives that will shed light on controversial issues and fallacies in Philippine history;
- b. understand the nature and background of controversial issues in Philippine history and help teachers deal with these topics; and
- c. know the implications of these issues in Philippine historical education with regards to teaching, research and textbook writing.
- 3. The participants are History/Makabayan/Social Studies teachers and supervisors from both public and private schools nationwide.
- 4. A registration fee of One Thousand Pesos (P1,000.00) will be charged each member and One Thousand Two Hundred Pesos (PhP 1,200.00) for non-member. This will cover 2 snacks, lunch, complimentary copy of Historical Bulletin, conference kit and certificate of participation.
- 5. Expenses of the public school participants such as transportation, board and lodging, meal allowance before and after the conference, conference fee and other expenses relative to this activity shall be charged against local funds (such as but not limited to PTCA, local school board funds, regional/division funds) or maybe sourced from the municipal/provincial funds or from civic spirited clubs, organizations and associations subject to the usual accounting and auditing rules and regulations. Participants from private schools may make arrangements with their respective school heads or with their PTCA President/Treasurer.
