The Commission on Elections, pursuant to the powers vested in it by the Constitution of the Republic of the Philippines, the Omnibus Election Code and other election laws, **RESOLVE** to prescribe, as it hereby prescribes, the following calendar of activities and periods of prohibited acts in connection with the October 29, 2007 Synchronized Sangguniang Kabataan and Barangay Elections:

The Executive Director and the Deputy Executive Director for Operations shall immediately implement this Resolution.

The Education and Information Department is directed to cause the widest dissemination of this Resolution and its publication in two (2) newspapers of general circulation in the Philippines.

This Resolution shall take effect on the seventh (7th) day after its publication.
