## EDUCATION SUPERVISORS TRAINING-WORKSHOP ON THE EVALUATION OF PROJECT PROPOSALS ON CURRICULUM INNOVATIONS

To: Regional Directors

Schools Division/City Superintendents

- 1. This Department is pleased to recognize the curriculum innovations that some secondary schools have initiated. In order to provide support and encourage more schools to enrich the curriculum in creative ways, the Bureau of Secondary Education (BSE) shall conduct the Education Supervisors Training-Workshop on the Evaluation of Project Proposals on Curriculum Innovations on November 5-9, 2007 at the Iloilo Grand Hotel, Iloilo City.
- 2. The Division Offices, through the Division Review Committee, shall review and evaluate the proposals on curriculum innovations which shall be approved by the Regional Office. In order to perform their roles more efficiently, there is a need to develop the capacity of the Education Supervisors in evaluating proposals on curriculum innovations.
- 3. The participants are the SDS-designated Chair of the Division Review Committee (ES I), and Chief/Assistant Chief of the Regional Secondary Education Division. The allocation of ES I participants per region shall be as follows:

Board and lodging of participants and training staff, transportation, per diem and extra duty allowance of training staff, training kit, supplies and materials, honoraria of resource persons, and other incidental expenses shall be charged against DepED HRDT funds subject to the usual accounting and auditing rules and regulations. Transportation and per diem of the participants shall be charged against local funds.

- 5. Division Supervisors that are not recommended by the Regional Office but would like to participate in the training shall be charged a registration fee of Five Thousand Pesos (PhP5,000.00) to cover board and lodging, training kit, and other training related expenses. Their registration fee, and other incidental expenses to be incurred (by these participants) shall be charged against local funds.
- 6. The Regional Office through the SED Chief, must send the list of participants to Ms. Rosa Ligaya C. Domingo/Mr. Edward Garcia of the Staff Development Division, Bureau of Secondary Education (SDD-BSE) at telefax no. (02) 632-7586 on or before October 29, 2007.
