8<sup>TH</sup> ANNUAL NATIONAL CONVENTION OF THE PHILIPPINE ASSOCIATION  
OF EDUCATION SUPERVISORS, INC. (PAES, INC.)

To: Regional Directors  
Schools Division/City Superintendents

1. The Philippine Association of Education Supervisors, Inc., (PAES, Inc.) will hold its 8<sup>th</sup> Annual Convention on November 27-29, 2007 at Family Country Hotel at Metro Road, Lagao, General Santos City with the theme **"Bridging Educational Gaps Towards Global Competitiveness"**.

2. The convention aims to:

- a. identify educational gaps and the creative ways of bridging such;
- b. share best practices on bridging educational gaps;
- c. promote cohesive partnership between and among the education stakeholders; and
- d. sustain the binding relationship between and among PAES members.

3. All division and regional supervisors/coordinators, are authorized to attend the 3-day convention on **official business**.

4. A registration fee of Four Thousand Two Hundred Pesos (P4,200.00) will be charged each participant to defray expenses for hotel accommodation, meals, handouts/convention kits, speakers' honoraria and other operational expenses. The registration, travel and other operational expenses shall be charged against local funds subject to the usual accounting and auditing rules and regulations.

5. Participants are expected to register on November 26, 2007. Since not everybody will be accommodated at the seminar venue whereby spillover will be housed at nearby hotels like Phela Grande Hotel and/or Sydney Hotel, the first-come, first-served policy will be observed. PAES officers and board members as well as committee members are expected to be at the venue two (2) days before and to stay one (1) day after the convention. This is for briefing and evaluation purposes. The first meal will be the snack on Day 0, November 26 while the last meal (packed lunch) shall be served on November 29, 2007.
